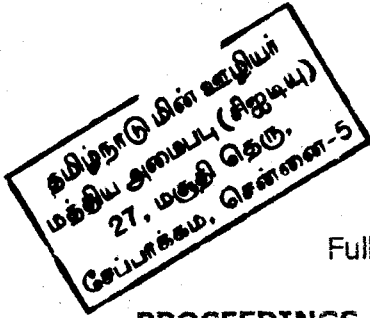

PROCEEDINGS :

In Annexure-I to Regulation 92 of Tamil Nadu Electricity Board Service Regulations regarding method of appointment, it has been prescribed that a Revenue Supervisor having not less than seven years of experience as Revenue Supervisor shall be considered for promotion to the post of Assessment Officer.

2) In the orders under reference cited, the Tamil Nadu Electricity Board directed that the existing minimum period of service of seven years as "Revenue Supervisor" prescribed for promotion to the post of Assessment Officer, shall be modified as Five years.

3) Some of the Unions have represented to delete the condition of period of seven years experience, and also some other Unions have represented to reduce as Four years so as to enable the incumbents to get promotion to the post of Assessment Officer for preparation of panel on the Crucial date (i.e.) on 05.07.2012.

4) The above request was examined by the Board, and it has been decided and hereby ordered that the existing minimum service experience of Five years in the post of Revenue Supervisor prescribed for promotion to the post of Assessment Officer be resolved to relax from 5 years to 4 years experience in the post of Revenue Supervisor as a one time relaxation only as a Special Case, for the preparation of Panel on the Crucial Date 05.07.2012.
