It is informed that in the Board proceedings under reference first, second and third cited, orders were issued for promoting 443 Accounts Supervisors to the post of Assistant Accounts Officers except the Accounts Supervisors who had passed B.Com., degree through Open University System without passing +2, since orders have been issued under reference fourth cited that the persons who possess a Diploma degree or post graduate after a pass in SSLC (10th std), HSC (+2), Basic degree, as the case may be shall only be considered for appointment/Promotion in the services of the TANGEDCO.

2) Further, the Hon'ble High Court in its order dated 27.06.2012 made in Writ Petition No.7276 to 7278 of 2012 stated (in Para 30(i)) that for the limited purpose of exemption from passing departmental examination, Open University Degrees can be considered. As per the above Hon'ble High Court order dated 27.06.2012, 94 Accounts Supervisors are promoted to the post of Assistant Accounts Officers based on their degree qualification acquired through Open University System vide reference sixth cited. In order to consider the persons who have acquired degree qualification through Open University System, orders have been issued to consider them for promotion vide reference seventh cited.

3) The Individuals who were deferred/not selected in the earlier panel due to their OUS qualification and subsequently considered have represented with certain Unions to restore their original seniority as their Juniors had already been promoted as Accounts Officers and Deputy Financial Controllers.

4) After careful consideration, the CMD/TANGEDCO has approved the proposal to restore the original seniority of the above said individuals on promotion.

5) Accordingly, it is hereby ordered that the inter-se-seniority in respect of the following 48 Accounts Supervisors provisionally selected for inclusion in the panel for promotion to the post of Assistant Accounts Officers in Class II service of the TANGEDCO under reference third, fifth and sixth cited are hereby fixed in the rank indicated against the names and included in the panel communicated in the (Per) B.P (Ch) No.4 (Adm.Branch) dated 11.01.2010 and (Per) CMD/TANGEDCO Proceedings No.7 Adm.Branch dated 08.02.2011 subject to out come of the WP.(MD) No.5161 of 2013 pending before the Hon'ble Madurai Bench of Madras High Court as mentioned below:-
