PROCEEDINGS:-

In the Board's Proceedings first and second cited, orders were issued for creation of 126 and 19 posts of Assessment Officers in O&M Divisions respectively. In the Board's Proceedings 3<sup>rd</sup> cited orders were issued for creation of 25 posts of Assessment Officers in the Pay band of Rs.15700-39100 + Rs.5400 Grade Pay for the remaining Divisions.

2) Based on the demand of the Unions it has been agreed among other things in the Wage/Work Load Settlement secured under section 12 (3) of the Industrial Disputes Act, 1947 dated :09.01.2014, that 42 posts of Assessment Officers will be created in the Distribution Circle Offices. Accordingly, it is hereby ordered for creation of 42 posts of Assessment Officers in Distribution Circle Offices in the Pay Band of Rs.15700-39100 + Rs.5400/-G.P.

3) The newly created Assessment Officers shall look after the works relating to the Circles concerned as in the case of existing Assessment Officers in the Division Offices.

4) The incumbents of the posts sanctioned in para-2 above will be eligible to draw the usual Pay, Dearness Allowance, House Rent Allowance etc., at the rates admissible under the orders in force, wherever applicable.

5) The expenditure is debitabale to "TANGEDCO Funds – Revenue Expenses – Distribution Circles – 75 Employees Costs".

6) The receipt of the Board's Proceedings shall be acknowledged.
