I am to state that the Junior Assistants/Typists/Steno-Typists (Accounts) mentioned in the Annexure, who have been selected for promotion to the post of Assistant (Accounts) in Class III Service, are allotted to your Circle for appointment as Assistant (Accounts) against the existing vacancies.
