PROCEEDINGS:-

The Administration related matters are dealt with by Administrative Officer in Regional Offices and Thermal Power Stations and Assistant Administrative Officer in Circle Offices, Thermal Power Stations, Division and other Offices. The proposal for upgradation of Administrative Officer as Senior Administrative Officer in 9 Distribution Regional Offices and Assistant Administrative Officer as Administrative Officer in 42 Distribution Circle Offices was examined and it has been decided to create 9 posts of Senior Administrative Officer duly abolishing 9 posts of Administrative Officer in Distribution Regional Offices and to create 42 posts of Administrative Officer duly abolishing 42 posts of Assistant Administrative Officer in Distribution Circle Offices. The Chairman-cum-Managing Director/TANGEDCO has approved the proposal.

2. Accordingly, sanction is hereby accorded for creation of 9 posts of Senior Administrative Officer in the Pay Band of Rs.15,700-39,100+Rs.7,000/- Grade Pay in each Distribution Regional Office and creation of 42 posts of Administrative Officer in the Pay Band of Rs.15,700-39,100+Rs.6,200/- Grade Pay in each Distribution Circle Office for a period of one year from the date of utilization of the posts.

3. Consequent on the orders issued in para-2 above, 9 posts of Administrative Officer in the Pay Band of Rs.15,700-39,100+Rs.6,200/- Grade Pay in each Distribution Regional Office and 42 posts of Assistant Administrative Officer in the Pay Band of Rs.15,700-39,100+Rs.5,400/- Grade Pay in each Distribution Circle Office shall be abolished with effect from the date of utilization of the created posts.

4. The incumbents of the posts ordered in para-2 above will be eligible to draw the usual pay, Grade Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.

5. The expenditure is debitable to "TANGEDCO Funds – Revenue Expenses – 75 – Employees costs 75.1 – Salaries – 75.110 – Salaries Provincial".
