Sub: TANGEDCO – Establishment - Class-III service –
Selection Grade Assessors promoted as
Supernumerary Inspectors of Assessment –
Allowing an additional increment on the date of
regular promotion – Orders – Issued.

Based on the terms made in the Work Load Settlement dated: 12.11.2002, orders were issued in the Board's Proceedings 2nd cited promoting the Assessors who have completed 14 years of service as on 12.11.2002 as Supernumerary Inspectors of Assessment. It was also ordered that they shall be allowed the scale of pay of Inspector of Assessment.

2) In the reference 3rd cited, orders were issued allowing Special Grade to the employees to those who have no promotion even after completion of 20 years of service in one and the same post. Accordingly, the Selection Grade Assessors who have not accepted the revised norms as per the settlement under reference 1st cited and remained as Selection Grade Assessors were moved to Special Grade on completion of 20 years of service in the post of Assessor with an increment benefit. Further, on their promotion as Inspector of Assessment they were allowed promotion fixation with an increment benefit. The Supernumerary Inspectors of Assessment were allowed Special Grade without any incremental benefit. Also they were not allowed any increment on their regular promotion as Inspectors of Assessment since they were allowed promotion fixation on their promotion as Supernumerary Inspectors of Assessment.

3) The Unions have demanded that the Supernumerary Inspectors of Assessment also be allowed an increment on their promotion as regular Inspectors of Assessment to eliminate disparity among them.

4) The request has been examined in detail. After careful consideration, it is hereby ordered that the Supernumerary Inspectors of Assessment on their regular promotion as Inspector of Assessment be allowed an increment notionally from the date of their regular promotion as Inspectors of Assessment and the monetary benefit for the above increment shall be allowed from the date of issue of this order.

5) The Supernumerary Inspectors of Assessment covered under the (Per) B.P. (FB) No.68 (SB), dated: 25.11.2002 and retired before issue of this order shall also be allowed the above benefit for pensionary benefits.

6) The receipt of the Memo. shall be acknowledged.
