2. After detailed deliberations the following decisions are arrived:

2.	Double Channel	It has been decided to place the matter before the Board to be held in Jan. 2017.
3.	Condition of service regulations to be implemented for Mazdoor	Within 2 days decision will be taken.
4.	Absorption of Contract Labourers	The issue will be pursued and decision will be taken
5.	Sanction of 1046 part time workers	The issue will be pursued and orders will be issued before 31.1.2017.
6.	Relaxation of experience period for the post of IA/RS	The matter to be placed before the Board in Jan. 2017

7.	Promotion from RC to RA	To be issued tomorrow.
8.	Panel to be prepared from AE/Electrical to AEE/Electrical	Panel will be drawn before 15.1.2017.
9.	Attending to tapal given to various Unions	CE/Personnel has been requested to attend all tapals regularly without giving room for complaints as per the existing order/directives.
