Electricity – Extensive damage to the electrical distribution network in Chennai, Tiruvallur and Kanchipuram District due to Cyclone Vardah on 12.12.2016 - Staff deputed from other districts for quick restoration of supply - Provision of snacks, double and triple wages for the workmen, Vehicle hiring charges - Administrative approval - Accorded.

### PROCEEDINGS:

1. The Tamil Nadu Generation and Distribution Corporation Limited hereby approves food, tea, snacks and water expenses, pocket expenses, triple wages/double wages for the officers and staff who worked for quick restoration of power supply in Chennai, Kanchipuram and Tiruvallur Districts, transport expenses, vehicle hiring charges, JCB hiring charges, engagement of lorry for transport of material & opening of temporary advance by Superintending Engineers of Chennai North and Chennai South Region, towards the damages caused to the infrastructure of TANGEDCO due to Vardah Cyclone as detailed below:

- Necessary food, tea, snacks and water should be arranged to all the officers and staff including contract labourers involved in the power restoration works.
- Pocket expenses Rs.100/person per day to the staff involved in the restoration works.
- Triple wages to officers (upto the level of AEE) and staff deployed for the rectification works during holidays.
- Double wages to the officers (upto the level of AEE) and staff deployed for the rectification works during working days.

- v) Actual transport expenses to the deputed officers (upto the level of AEE) and staff from the place from where deputed to the work spot and back to place of deputation.
- vi) Payment of vehicle hiring charges and JCB hiring charges and engaging of Lorries for transport of material from stores to the work spot.
- vii) Superintending Engineers are authorized to draw the temporary advance in cash from headquarters.
2. By virtue of the provisions contained in sub-section (2) (a) of section 185 of the Electricity Act, 2003, TANGEDCO being the Licensee and successor entity of Tamil Nadu Electricity Board will exercise the powers of the Telegraph Authority under the provisions of section 164 of the Electricity Act, 2003, which have already been conferred upon the Board under section 51 of the Indian Electricity Act, 1910.


