Sub: TANGEDCO – COVID-19 outbreak – Extension of time (EOT) for LT/LTCT services in Chennai, Kanchipuram, Tiruvallur & Chengalpattu falls due dates between 25.03.2020 to 14.07.2020 till 15.07.2020 – PMC billing for LT/LTCT services in Chennai, Kanchipuram, Tiruvallur & Chengalpattu from 19.06.2020 to 30.06.2020 - Extension of time (EOT) for HT services - for the HT assessment months 02/2020, 03/2020, 04/2020 & 05/2020 till 15.07.2020 – Reg.

1.0 In view of the COVID-19 outbreak, there has been lock down since 24.03.2020 midnight. Now, the Government of Tamil Nadu has announced extension of complete lockdown for the period from 19.06.2020 to 30.06.2020 with certain exceptions in Chennai, Kanchipuram, Tiruvallur & Chengalpattu. In continuation to the instructions issued vide reference 1st to 10th cited, based on the CMD's Note approval 11th cited, the following further instructions are issued:-

a) Extension of time for payment of all LT and LTCT consumers Chennai, Kanchipuram, Tiruvallur & Chengalpattu whose last date for payment falls between 25.03.2020 to 14.07.2020 shall be granted up to 15.07.2020, without levy of BPSC and DC-RC fees and TANGEDCO officials are instructed not to disconnect the services up to 15.07.2020.

b) To adopt previous month billing (PMC billing) for the LT and LTCT services located in Chennai, Kanchipuram, Tiruvallur & Chengalpattu Districts whose reading date is from 19-06-2020 to 30-06-2020 (i.e. to adopt the amount billed for February2020/May 2020, as the case may be, as bill amount for June 2020).

c) As per Proceeding No. 90 dated 15.06.2020 issued by the Government of Tamil Nadu, banks will not be functioning during the above period resulting in lack of

remittance facilities and to avoid inconvenience to the Consumers of TANGEDCO, the collection counters of TANGEDCO located in Chennai, Kanchipuram, Tiruvallur & Chengalpattu Districts shall not function from 19-06-2020 to 30-06-2020.

d) The LT and LTCT consumers may be advised to make use of online payment facilities such as Internet banking, Mobile Banking, Payment Gateway, BBPS etc., for the payment of Current Consumption Charges and other charges during the period from 19-06-2020 to 30-06-2020, as a precautionary measure.

2.0) The following instructions are issued for all HT consumers,

a) In respect of the HT services which have not made payment within the due dates for the HT assessment months 02/2020, 03/2020, 04/2020 & 05/2020 payable during March 2020, April 2020, May 2020 and June 2020 respectively and for which TANGEDCO has foregone its right to disconnect, such HT services can make the payment up to 15.07.2020. TANGEDCO shall not resort to disconnection until 15.07.2020.

b) The HT consumers may be advised to make use of the RTGS facility for payment. However, the collection counters at the Circle office shall also be available for facilitating payment.

3.0) The Superintending Engineers of EDCs are instructed to communicate the above to all the officials concerned for necessary action.
