Sub: TANGEDCO – COVID-19 outbreak – LT due dates between 25.03.2020 to 30.04.2020 – Extension of time (EOT) for such LT services upto 06.05.2020 - as a precautionary measure – PMC Billing upto 30.04.2020 – Instruction issued – Reg.

In view of the COVID-19 outbreak, and lock down since 24.03.2020 midnight, considering the difficulties faced by the LT consumers of TANGEDCO, it was informed that in respect of LT services whose last date for payment of Current Consumption Charges & other arrear payments was between 25.03.2020 to 14.04.2020, the time for such payment was extended up to 14.04.2020. The Government of Tamil Nadu have announced extension of lock down till 30.04.2020. In order to avoid inconvenience that would be faced by the public while arranging for payment after 30.04.2020, TANGEDCO issues the following instructions:

a) Extension of last date for payment of all LT and LTCT consumers whose due dates fall between 25.03.2020 to 30.04.2020 as 06.05.2020 without levy of BPSC and DC-RC fees.

b) To adopt previous month billing (PMC billing) for the LT and LTCT services whose bill month is March 2020/April 2020 and the reading date is from 22.03.2020 to 30.04.2020 (i.e. to adopt the amount billed for January 2020/February 2020/March 2020, as the case may be, as bill amount for March 2020/April 2020).

c) The LT and LTCT consumers of TANGEDCO may be advised to make use of online payment facilities such as Internet banking, Mobile Banking, Payment Gateway, BBPS etc., for the payment of Current Consumption Charges and other charges, as a precautionary measure.

2.0) The Superintending Engineer/EDCs are instructed to communicate the above to all the officials concerned for necessary action.
