PROCEEDINGS :

As per the Circular Memo cited, order has been issued to sanction the funeral expenses amount of Rs.5,000/- with effect from 18.01.2010 for the Fatal Accident.

2) The employees as well as the Unions have represented to consider and pay Special Grant for Funeral day expenses to the dependents to meet out the funeral expenses irrespective of cadre. They have requested to enhance the said compensation amount to Rs.25,000/-.

3) As a gesture of goodwill, CMD/TANGEDCO has approved the proposal accordingly.

Hence it is hereby ordered that the "Special Grant for Funeral day expenses" for a sum of Rs.25,000/- (Rupees Twenty five thousand only) be paid to the dependents of the employees of TANGEDCO/TANTRANSCO irrespective of cadre due to fatal accident while on duty. The amount shall not be adjusted/recovered in the future payments due for the deceased.

4) The power is delegated to the Superintending Engineers to sanction and disburse the "**Special Grant for Funeral expenses**" amount to the dependents of the employees on the day of death/funeral.

The date of implementation of order will be effect from 08.02.2021

The expenditure is debitable to the head of A/c No. **75.715**

5) The receipt of the Proceedings shall be acknowledged.
