Sub: TANGEDCO - New Health Insurance Scheme, 2021-Eligibility of Gangman (Trainees) appointed on consolidated pay for a period of two years-coverage under New Health Insurance Scheme, 2021-Orders issued.

In the Government Order first cited, orders have been issued for implementation of the New Health Insurance Scheme, 2021 to provide Health Care Assistance to the Employees of Government Departments, Public Sector undertakings, Statutory Boards, Local Bodies, State Government Universities, willing State Government Organisations/Institutions and their eligible Family Members with provision to avail assistance upto the limit of Rupees Five Lakh in a block of four years commencing from 01.07.2021 to 30.06.2025.

2. Based on the above orders of Government of Tamil Nadu, the New Health Insurance Scheme 2021 was implemented in this Corporation to provide Health Care Assistance to the employees of TANGEDCO/TANTRANSCO & TNEB Ltd., and their eligible family members vide Proceedings second cited.

3. In the Government Letter fourth cited it is clarified that Gangman (Trainees) appointed on consolidated pay in TANGEDCO for two years period and subsequently being brought under regular time scale of pay after completion of two years shall be made eligible for coverage under New Health Insurance Scheme, 2021.

4. In continuation of the orders issued in the reference second cited, it is hereby ordered as follows:

(i) The enrolment of the Gangman (Trainees) under the New Health Insurance Scheme, 2021 shall be **compulsory**. The monthly subscription per month under the New Health Insurance Scheme, 2021 shall be Rs. 300/- (Rs.295/- per month subscription for NHIS plus Rs.5/- per month contribution for corpus fund) and the recovery shall commence from the salary for the month of December 2021 onwards. The Gangman (Trainees) and their eligible family members are covered under New Health Insurance Scheme, 2021.

ii) The existing terms and conditions as ordered in the reference second cited, shall be followed.

5. The pay drawing officers are requested to distribute the enclosed Annexure (as prescribed in the G.O. Ms. No. 160 Finance (Salaries) Department, dated 29.06.2021 Annexure-VI) to the Gangman (Trainees) and to furnish the latest details of himself/herself and their eligible family members along with the recent passport size photographs in the prescribed form.

6. The pay drawing officers are requested to collect the filled in the Annexure as mentioned above from the Gangman (Trainees) under their control and to verify, countersign and hand it over to the MDIndia Health Insurance (TPA) Pvt. Ltd., Guna Complex, #443, 445, Anna Salai, Teynampet, Chennai 600 018 under intimation to this office.
