In the reference (10) cited above, it was informed that, depending upon the increasing rate of COVID 19 infection the districts were classified into 3 groups. The districts that fall under Group I are Coimbatore, Nilgiris, Tiruppur, Erode, Salem, Karur, Namakkal, Thanjavur, Thiruvarur, Nagapattinam and Mayiladuthurai. The lockdown with the same restrictions continue in the 11 districts under Group I.

2.0) In this connection, now it is informed that the methodology of PMC communicated in reference (7) cited above may be adopted for June-2021 assessment also only in the following circles covered in the anove mentioned 11 districts.

3.0) Where the assessment date for the LT service connections fall during the period between 15.06.2021 & 30.06.2021 (i.e the 60th day from the preceding bill month's reading date), such consumers may be permitted to provisionally make payment based on the amount billed for June 2019 (Non-Covid Period). For the new consumers or consumers who do not have billing for June 2019 or consumers who felt that billing based on June 2019 is excessive may be permitted to provisionally make payment based on the amount billed for April 2021. The said payments made will be adjusted/regularized after ascertaining the reading during the next assessment of the respective CC bills. i.e the payment of June 2021 will be adjusted in the bill for the month of August 2021.

4.0) The consumers may be advised to make use of online payment facilities such as Internet banking, Mobile Banking, Debit/Credit Cards, BBPS etc., for the payment of Current Consumption charges and other charges, as a precautionary measure.
