2) On conversion as Junior Assistant (Adm.), they are posted to the circle as mentioned against their names after obtaining undertaking for the following conditions:

- i) that they should forfeit their lien in the post of Assessor and join duty as Junior Assistant (Adm.).
- ii) that they should not claim any Seniority and Promotion in the Assessor Cadre in future.
- iii) that they should not claim the lien again in the post of Assessor.
- iv) that they should take last rank in the post of Junior Assistant (Adm.) i.e. Junior to Junior most in the said cadre.

3) They should await further reposting orders from the Superintending Engineers Concerned and join in the new post immediately on receipt of reposting orders.

4) They are not eligible for Transfer Travelling Allowance as the conversion and posting as Junior Assistant (Adm.) have been ordered at their own request.
