In the Board's Proceedings cited, orders were issued to cancel/dispense off with the scheme of deduction of Annual Union Subscription/Donation from the salary of the employees of TANGEDCO.

2. Various Unions had represented for retaining the above system. In case of their request, the matter has been examined and it is hereby ordered that deduction of Annual Membership fees from the salary of willing Member employees to their Unions may be permitted as per Payment of Wages Act, 1936.

3. The Member employees shall submit their willingness to the Controlling Officer/Pay disbursing Officer for the above deduction. An employee shall be permitted deduction of only one Membership fee.

4. The receipt of the Memo. shall be acknowledged.
