3. The pay of the above said Administrative Supervisors possess fixed in the post of Assistant Administrative Officer under Regulation 33(b) of TNEB Service Regulations.

4. The Superintending Engineers concerned are directed to serve the appointment-cum-posting orders to the officers only if they are free from D.P./undergoing punishment/Vigilance remarks.

5. They should join duty in the new post immediately. If they do not join duty within 15 days from the date of receipt of this order, their promotion orders will be cancelled and next junior will be promoted.

6. Any request for modification/cancellation in the place of posting will not be entertained under any circumstances.

7. An option form for fixation of pay is enclosed. The promotee is directed to submit the option form duly filled in to the Superintending Engineers within one month from the date of joining as Assistant Administrative Officer on their promotion. They are further informed if the option format is not submitted within the above said period of one month, their pay in the higher post will be fixed as specified in para-3 of Board's Secretariat Branch Memo.No.75405/P1/ 90-1, dated 19.03.1991.
