The promotee is directed to submit the option form duly filled in, to the Superintending Engineer's within one month from the date of joining as Accounts Officer on their promotion. They are further informed if the option format is not submitted within the above said period of one month, their pay in the higher post will be fixed as specified in para-3 of Board's Secretariat Branch Memo.No.75405/P1/ 90-1, dated 19.03.1991.
