Establishment – TANGEDCO – Constitution of a committee for redressal of Grievances of Gangmen – Orders – Issued.

PROCEEDINGS:-

In the Proceedings first read above, 5000 new posts in the nomenclature of Gangman were created in TANGEDCO to carry out lot of ground works viz., Digging, Erection of poles and allied non-technical works. Based on the creation of the above said new posts, notification have been issued for calling for applications for filling up of the above said posts.

2. To fill up the above said posts, applications have been called for from the eligible candidates in the notification second read above. Based on the notification, 90,124 candidates had applied for the said post. The selection process comprising of physical as well as written test. Out of 90,124 candidates, 15,106 candidates have passed in the physical examination. Subsequently, they have been permitted to appear the written examination.

3. In the Proceedings third read above, orders have been issued by increasing the vacancies in the post of Gangman from 5000 to 10000 posts for Direct recruitment of Gangmen (Trainee). Accordingly, 9,613 candidates out of 15,106 candidates have been selected by following the rule of reservations. However, there were so many cases in which Writ Petitions have been filed by various candidates before the Hon'ble Court of Law against the recruitment of these posts. However, the Hon'ble Court in its orders dated 22.02.2021 in W.P. No.9068/2019 ordered to give appointment to the selected candidates. Accordingly, based on the orders and by following the rules of reservation 9,613 candidates have been selected and got appointment as Gangmen. The remaining 5,493 non-selected candidates who have passed in the physical examination have frequently represented to absorb them in the post of Gangmen.

4. Now, it has been proposed to constitute a Committee to examine the grievances of the remaining 5,493 selected candidates by taking into consideration the pros and cons of their grievances. Accordingly, the Committee is constituted with the following members to redress the Grievances of the remaining 5,493 non-selected candidates :-
