New Health Insurance Scheme 2016/2021 – Inclusion
of Gangman (Trainees) and their family members –
Subscription towards NHIS effect from December'2021 –
Refund of the amount deducted towards NHIS 2016/2021
from the Gangman from the date of joining – Orders - issued.

In the Government order dated 29.06.2021 orders have been issued implementing the New Health Insurance Scheme, 2021 to provide Health Care Assistance to the employees of Government Departments, Public Sector undertakings, Statutory Boards, Local Bodies, State Government Universities, willing State Government Organisations/Institutions and their eligible family members for four years commencing from 01.07.2021 to 30.06.2025. Based on the above orders of Government of Tamil Nadu, the New Health Insurance Scheme 2021 was implemented in this corporation to provide Health Care Assistance to the employees of TANGEDCO/ TANTRANSCO & TNEB Ltd., and their eligible family members vide Proceedings dated 17.07.2021.

2. In continuation of the above orders in the Memo. dated 18.12.2021, orders have been issued including the Gangman (Trainees) and their eligible family members under the coverage of New Health Insurance Scheme' 2021, and the enrollment of the Gangman (Trainees) under the New Health Insurance Scheme' 2021 compulsory. It was also ordered that the monthly subscription shall commence from the salary for the month of December' 2021 onwards.

3. It was brought to the notice that, in certain distribution circles the subscription towards NHIS' 2016/2021 from the Gangman (Trainee) has been recovered from the date of their joining. The matter was examined and it has been decided to refund the amount to the Gangman (Trainees) from whom the subscription towards NHIS has been deducted from their salary from the date of joining and till November' 2021, since the Gangman has been included in the said Scheme with effect from December'2021 only.

Accordingly all the Chief Engineers, Superintending Engineers are requested to give necessary instructions to their pay drawing officer's to refund the subscription towards NHIS' 2016/2021 to the Gangman (Trainees) from whom the amount has been deducted from their date of joining and upto November' 2021, if it has been deducted from their salary.
