The allotment order issued to the Junior Engineer's/Elecl.-II Gr as Junior Engineer/Elecl.-I Gr., to Generation Circle/Kundah, (Sl.No. in the selection list 322 to 327), vide this office Memo. under reference 3<sup>rd</sup> cited, is hereby cancelled, on administrative grounds and re-allotment order issued.

2) Under Regulation 106 of the T.N.E.B. Service Regulation, the following Junior Engineer's/Electrical II Grade, who have been selected for promotion as Junior Engineer/Electrical I Grade in the reference 1st cited, are promoted on temporary basis as Junior Engineer/Electrical-I Grade and allotted to the circles as noted against their names. The Superintending Engineer's concerned are informed to issue appointment on promotion on temporary basis, under Regulation 106 of S.R. and necessary reposting orders to the promotee.

8) The Superintending Engineers concerned are also informed to issue suitable instructions to the Officer concerned to relieve the officials within 2 weeks from the date of issue of appointment and posting orders without waiting for joining of substitute.

9) The Superintending Engineers concerned are further informed that the promotees may be informed that their representation for modification of the orders will not be entertained and if they fails to join duty within 10 days from the date of relief, necessary action will be taken to cancel the appointment orders. The same may be closely watched and reported.
